**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Parker:

Please be advised that as of 13 July 2012, Ynot Domains Corp. ("Ynot Domains") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 21 April 2010 ("RAA"). These breaches result from:

1. Failure to escrow gTLD registration data pursuant to Section 3.6 of the RAA; and
2. Failure to pay past due accreditation fees pursuant to Section 3.9 of the RAA.

Please refer to the attachment below for details regarding these breaches. ICANN requests that Ynot Domains cure the breaches by 3 August 2012, 15 working days from the date of this letter, by taking the following actions:

1. Deposit gTLD registration data on a weekly basis to Iron Mountain Intellectual Property Management, Inc. ("Iron Mountain"); and
2. Pay all past due accreditation fees in the amount of \$2,453.69.

If Ynot Domains fails to timely cure these breaches, ICANN may commence the termination process.

## ATTACHMENT

### Failure to Escrow gTLD Registration Data

Section 3.6 of the RAA requires Ynot Domains, “on a schedule, under the terms, and in the format specified by ICANN” to “submit an electronic copy of the database described in Subsection 3.4.1 (of the RAA) to ICANN or, at its expense, to a reputable escrow agent mutually approved by Registrar and ICANN.”

Our records show that Ynot Domains is required to escrow data with Iron Mountain on a weekly basis. However, based on the reports provided by Iron Mountain to ICANN, over the past few months, it appears that Ynot Domains repeatedly failed to deposit data.

The last full successful deposit by Ynot Domains was received on 2 April 2012. As such, Ynot Domains has missed 14 required data escrow deposits from 9 April 2012 until 9 July 2012. It is clear that Ynot Domains repeatedly failed to escrow registration data and such failure constitutes a breach of Section 3.6 of the RAA.

### Failure to Pay Accreditation Fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Ynot Domains currently owes ICANN \$2,453.69 in past due accreditation fees.

Ynot Domains failed to comply with its obligation pursuant to Section 3.9 of the RAA by failing to timely pay accreditation fees.
