RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Smirnoff:

Please be advised that the Registrar Accreditation Agreement (RAA) between the Internet Corporation for Assigned Names and Numbers (ICANN) and DNGLOBE LLC (DNGLOBE) is terminated and, consistent with the terms of the RAA, the termination shall become effective on 22 February 2010. As explained in greater detail below, this termination is based on DNGLOBE's failure to cure the breach set forth in ICANN's letter dated 14 January 2010.

ICANN demands that DNGLOBE remove all ICANN's trademarks immediately from DNGLOBE's website and business materials that were licensed to DNGLOBE under the terms of the logo license Appendix to the RAA, as this logo license is revoked.

Be further advised that VeriSign, Inc. (VeriSign), the registry for .net and .com TLDs, may commence deleting domain names currently managed by DNGLOBE on 15 February 2010, or shortly thereafter, based on DNGLOBE's failure to cure breaches cited by VeriSign in its notice of breach of registry-registrar agreement. You are encouraged to contact ICANN's Registrar Liaison Manager, Brian Peck at brian.peck@icann.org to designate a bulk transfer recipient on or before 10 February 2010.

Failure to pay accreditation fees pursuant to Section 3.9 of the RAA

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. DNGLOBE currently owes ICANN \$2,203.16 in past due accreditation fees.

Notices regarding DNGLOBE's past due accreditation fees, including detailed customer statements, were transmitted to DNGLOBE on 23 October 2009 and 14 January 2010.

On 14 January 2010, ICANN sent DNGLOBE a notice of breach of its RAA based on DNGLOBE's failure to pay past due accreditation fees. DNGLOBE failed to cure this breach in the time period allowed by the RAA.

Based on DNGLOBE's failure to cure the breach of Section 3.9, and in accordance with Section 5.3 and 5.3.4 of the RAA, ICANN hereby gives DNGLOBE notice that DNGLOBE's accreditation will terminate on 22 February 2010.

Additional ICANN Concerns: Failure to Provide Public Access to Data on Registered Names Pursuant to Section 3.3 of the RAA

Section 3.3.1 of the RAA requires DNGLOBE to "provide an interactive web page and port 43 Whois service providing free public query-based access to up-to-date (i.e., updated at least daily) data concerning all active Registered Names sponsored by Registrar for each TLD in which it is accredited," such data to include:

- 3.3.1.1 The name of the Registered Name;
- 3.3.1.2 The names of the primary nameserver and secondary nameserver(s) for the Registered Name;
- 3.3.1.3 The identity of Registrar (which may be provided through Registrar's website);
- 3.3.1.4 The original creation date of the registration;
- 3.3.1.5 The expiration date of the registration;

3.3.1.6 The name and postal address of the Registered Name Holder;

3.3.1.7 The name, postal address, e-mail address, voice telephone number, and (where available) fax number of the technical contact for the Registered Name; and

3.3.1.8 The name, postal address, e-mail address, voice telephone number, and (where available) fax number of the administrative contact for the Registered Name.

ICANN notified DNGLOBE on 4 January 2010 of DNGLOBE's obligation to provide an interactive web page and web-based Whois service. ICANN attempted to access DNGLOBE's interactive web page several times over the past month, including an attempt on 3 February 2010. ICANN's attempts found that DNGLOBE does not have a working interactive web page and web-based Whois service. DNGLOBE's failure to provide a working interactive web page and web-based Whois service constitutes a breach of Section 3.3 of the RAA. As DNGLOBE has failed to cure its violation of Section 3.9 within the time allowed under the RAA, the RAA will be terminated on those grounds, independent of the separate breach, or time to cure the breach, of Section 3.3.

Conclusion

Based on DNGLOBE's failure to cure the breach set forth in ICANN's notice of breach dated 14 January 2010, ICANN is terminating the RAA, effective 22 February 2010. In the interest of protecting domain name registrants, ICANN must immediately commence the domain name transition process and solicit bids for a qualified ICANN accredited registrar to manage the domain names currently managed by DNGLOBE.

To facilitate the transition of the domain names currently managed by DNGLOBE, ICANN will follow its De-Accredited Registrar Transition Procedure (Procedure) <http://www.icann.org/en/processes/registrars/de-accredited-registrar-transition-procedure-01oct08.pdf>. ICANN encourages DNGLOBE to read the Procedure in its entirety. Consistent with the Procedure, we are requesting that DNGLOBE designate a transfer recipient on or before 10 February 2010. Please contact ICANN's Registrar Liaison Manager, Brian Peck at brian.peck@icann.org to designate a bulk transfer recipient. We anticipate the full cooperation of DNGLOBE during the transition.

Kindly note, however, that your designation of a bulk transfer recipient does not prejudice ICANN's right to the Registration Data Escrow data and other rights under the RAA, as well as ICANN's right to transfer domain names to a registrar of our choosing pursuant to the Procedure.

Be advised that termination of DNGLOBE's RAA does not relieve DNGLOBE of the obligation to pay accreditation fees thereunder, which should be paid immediately. ICANN reserves the right to pursue all means available to collect all accreditation fees owed by DNGLOBE, including the past due amount of \$2,203.16.

It is ICANN's goal to protect registrants from unnecessary harm and we look forward to amicably resolving any domain name transition issues that may arise from this termination.
