

## **Amendment No. 3 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers + Machines Group Limited agree, effective as of \_\_\_\_\_ (“Amendment No. 3 Effective Date”), that the modification set forth in this amendment No. 3 (the “Amendment”) is made to the 09 January 2014 **.LUXE** Registry Agreement between the parties, as amended (the “Agreement”).

The parties hereby agree to amend Exhibit A of the Agreement by deleting section 4 in its entirety:

### **“4. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

**4.1.** Registry Operator must offer Registrars support for handling IDN registrations in EPP.

**4.2.** Registry Operator will not offer variant IDNs.

**4.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):

**4.3.1.** Spanish Language

**4.3.2.** German Language

**4.3.3.** French Language

**4.3.4.** Italian Language

**4.3.5.** Russian Language

**4.3.6.** Danish Language

**4.3.7.** Finnish Language

**4.3.8.** Norwegian Language

**4.3.9.** Swedish Language

**4.3.10.** Hebrew Language

**4.3.11.** Arabic Language”

The parties hereby further agree to amend Exhibit A of the Agreement by replacing the deleted section above with new text as a new section 4:

**“4. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

**4.1.** Registry Operator must offer Registrars support for handling IDN registrations in EPP.

**4.2.** Registry Operator must handle variant IDNs as follows:

**4.2.1.** Variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) will be blocked from registration.

**4.3.** Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):

**4.3.1.** Arabic Language

**4.3.2.** Chinese Language

**4.3.3.** Danish Language

**4.3.4.** Finnish Language

**4.3.5.** French Language

**4.3.6.** German Language

**4.3.7.** Hebrew Language

**4.3.8.** Italian Language

**4.3.9.** Russian Language

**4.3.10.** Spanish Language

**4.3.11.** Swedish Language

**4.3.12.** Norwegian Language”
