RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Tesler:

Be advised that as of 15 April 2010, Mobiline USA, Inc., dba domainbonus.com (“Mobiline”) is in breach of the Internet Corporation for Assigned Names and Numbers’ Registrar Accreditation Agreement (“RAA”). This breach results from Mobiline’s failure to escrow gTLD registration data pursuant to Section 3.6 of the RAA. Should Mobiline fail to cure this breach within 15 working days, ICANN may commence the termination process as set forth in section 5.3.4 of the RAA.

Failure to Escrow gTLD Registration Data

Section 3.6 of the RAA requires Mobiline to, “on a schedule, under the terms, and in the format specified by ICANN” to “submit an electronic copy of the database described in Subsection 3.4.1 [of the RAA] to ICANN or, at its expense, to a reputable escrow agent mutually approved by Registrar and ICANN.”

To date, Mobiline has failed to comply with its obligation pursuant to Section 3.6 of the RAA by not escrowing data with Iron Mountain Intellectual Property Management, Inc (“Iron Mountain”), the ICANN approved escrow agent, or another reputable escrow agent approved by ICANN.

ICANN provided notice to Mobiline concerning Mobiline’s obligation to escrow its gTLD registration data early in 2008. Mobiline acknowledged this obligation by signing a data escrow agreement with ICANN and Iron Mountain on 17 September 2008. More recently, ICANN reminded Mobiline on 4 December 2009 of Mobiline’s obligation to begin to escrow gTLD registration data. To date, Mobiline has not escrowed gTLD registration data as required by Section 3.6 of the RAA.
