24 Defendant ICM Registry, LLC, d/b/a .XXX (“Defendant” or “ICM”) hereby
25 responds to the First Amended Complaint of Plaintiffs Manwin Licensing
26 International S.A.R.L. (“Manwin”) and Digital Playground, Inc. (“Digital
27 Playground”) (collectively “Plaintiffs”) as follows:

I. NATURE OF THE ACTION

- 1. ICM lacks sufficient information to form a belief as to the truth of the allegations of Paragraph 1 and therefore denies those allegations.
- 2. ICM admits Plaintiffs have initiated the present lawsuit that purports to be an action for antitrust violations under the Sherman Antitrust Act, 15 U.S.C. §§ 1, 2. ICM denies any unlawful monopolistic conduct, price gouging, or anti-competitive and unfair practices. ICM denies the remaining allegations of Paragraph 2.
- 3. ICM lacks sufficient information to form a belief as to the truth of the allegations of Paragraph 3 relating to the control and responsibility of Defendant Internet Corporation for Assigned Names and Numbers (“ICANN”) for the Internet Domain Name System (“DNS”) and therefore denies those allegations. ICM admits that ICANN recently approved the .XXX Top Level Domain (“TLD”), and contracted with ICM to make ICM the registry of that TLD. ICM admits that the annual cost of an .XXX registration is \$60, plus a \$2 fee for ICANN pursuant to the Registry Agreement, for a total of \$62 for .XXX TLD registrations. ICM denies the remaining allegations of Paragraph 3 and each of its subparagraphs.

II. THE PARTIES

- 4. ICM lacks sufficient information to form a belief as to the truth of the allegations of Paragraph 4 and therefore denies those allegations.
- 5. ICM lacks sufficient information to form a belief as to the truth of the allegations of Paragraph 5 and therefore denies those allegations.
- 6. ICM lacks sufficient information to form a belief as to the truth of the allegations of Paragraph 6 and therefore denies those allegations.
- 7. ICM denies it is a Delaware limited liability corporation, but admits that it is a Delaware limited liability company. ICM admits its principal place of business in is Palm Beach Gardens, Florida. ICM admits that it conducts business

1 in California. ICM admits that it has a contract with ICANN to operate the registry
2 for the .XXX TLD. ICM denies the remainder of the allegations in Paragraph 7.

3 8. Defendant denies the allegations of Paragraph 8.

4 **III. JURISDICTION AND VENUE**

5 9. ICM admits that Plaintiffs have initiated the present lawsuit, asserting
6 claims under the Sherman Antitrust Act, 15 U.S.C. §§ 1, 2. ICM admits that this
7 Court has subject matter jurisdiction under 28 U.S.C. §1331.

8 10. ICM lacks sufficient information to form a belief as to the truth of the
9 allegations of Paragraph 10 regarding personal jurisdiction over ICANN and
10 therefore denies those allegations.

11 11. ICM admits it is subject to personal jurisdiction in this Court for the
12 purposes of this action. ICM denies the remaining allegations of Paragraph 11.

13 12. ICM admits that venue in this judicial district is proper under 28
14 U.S.C. § 1391(b) and 15 U.S.C. § 22. ICM admits that it transacts business in
15 California and is subject to personal jurisdiction in this Court. ICM lacks
16 sufficient information or belief to answer the allegations relating to the other
17 defendants and to Plaintiff's residence, and therefore denies those allegations.
18 ICM denies the remaining allegations of Paragraph 12.

19 **IV. FACTUAL ALLEGATIONS**

20 13. ICM lacks sufficient information to form a belief as to the truth of the
21 allegations of Paragraph 13 and therefore denies those allegations.

22 14. ICM lacks sufficient information to form a belief as to the truth of the
23 allegations of Paragraph 14 and therefore denies those allegations.

24 15. ICM lacks sufficient information to form a belief as to the truth of the
25 allegations of Paragraph 15 and therefore denies those allegations.

26 16. ICM lacks sufficient information to form a belief as to the truth of the
27 allegations of Paragraph 16 and therefore denies those allegations.

28 ///

- 1 17. ICM lacks sufficient information to form a belief as to the truth of the
2 allegations of Paragraph 17 and therefore denies those allegations.
- 3 18. ICM lacks sufficient information to form a belief as to the truth of the
4 allegations of Paragraph 18 and therefore denies those allegations.
- 5 19. ICM lacks sufficient information to form a belief as to the truth of the
6 allegations of Paragraph 19 and therefore denies those allegations.
- 7 20. ICM lacks sufficient information to form a belief as to the truth of the
8 allegations of Paragraph 20 and therefore denies those allegations.
- 9 21. ICM lacks sufficient information to form a belief as to the truth of the
10 allegations of Paragraph 21 and therefore denies those allegations.
- 11 22. ICM lacks sufficient information to form a belief as to the truth of the
12 allegations of Paragraph 22 and therefore denies those allegations.
- 13 23. ICM lacks sufficient information to form a belief as to the truth of the
14 allegations of Paragraph 23 and therefore denies those allegations.
- 15 24. ICM lacks sufficient information to form a belief as to the truth of the
16 allegations of Paragraph 24 and therefore denies those allegations.
- 17 25. ICM lacks sufficient information to form a belief as to the truth of the
18 allegations of Paragraph 25 and therefore denies those allegations.
- 19 26. ICM lacks sufficient information to form a belief as to the truth of the
20 allegations of Paragraph 26 and therefore denies those allegations.
- 21 27. ICM lacks sufficient information to form a belief as to the truth of the
22 allegations of Paragraph 27 and therefore denies those allegations.
- 23 28. ICM lacks sufficient information to form a belief as to the truth of the
24 allegations of Paragraph 28 and therefore denies those allegations.
- 25 29. ICM lacks sufficient information to form a belief as to the truth of the
26 allegations of Paragraph 29 and therefore denies those allegations.
- 27 30. ICM lacks sufficient information to form a belief as to the truth of the
28 allegations of Paragraph 30 and therefore denies those allegations.

1 31. ICM lacks sufficient information to form a belief as to the truth of the
2 allegations of Paragraph 31 and therefore denies those allegations.

3 32. ICM lacks sufficient information to form a belief as to the truth of the
4 allegations of Paragraph 32 and therefore denies those allegations.

5 33. ICM lacks sufficient information to form a belief as to the truth of the
6 allegations of Paragraph 33 and therefore denies those allegations.

7 34. ICM admits that in about 2000, ICM Registry, Inc. applied to ICANN
8 for approval of the .XXX TLD for adult content. ICM admits ICANN did not
9 accept the application and noted in ICANN's "Report on TLD Applications:
10 Application of the August 15 Criteria to Each Category or Group" dated November
11 9, 2000, that "ICM Registry's application for an .xxx TLD does not appear to meet
12 unmet needs. Adult content is readily available on the Internet." ICM admits that
13 in its November 9, 2000 Report, ICANN "not[ed] the opposition of at least some
14 segments of the online content industry to a .xxx TLD." ICM lacks sufficient
15 information to form a belief as to the truth of the remaining allegations of
16 Paragraph 34 as to the basis of the opposition to the .XXX TLD and therefore
17 denies those allegations.

18 35. ICM admits it applied for ICANN's approval of the .XXX TLD as a
19 sponsored TLD in 2004. ICM lacks sufficient information to form a belief as to
20 the truth of the remaining allegations of Paragraph 35 and therefore denies those
21 allegations.

22 36. ICM admits that as part of its application in 2004, ICM proposed the
23 International Foundation for Online Responsibility ("IFFOR") as the sponsoring
24 organization for the .XXX TLD. ICM denies the remaining allegations of
25 Paragraph 36.

26 37. ICM admits that on or about August 2004, ICANN did not accept
27 ICM's application, and invited ICM to clarify its sponsorship criteria. ICM denies
28 the remaining allegations of Paragraph 37.

1 38. Paragraph 38 contains no charging allegations against ICM. ICM is
2 therefore not required to admit or deny the allegations. Alternatively, ICM lacks
3 sufficient information to form a belief as to the truth of the allegations of
4 Paragraph 38 and therefore denies the same.

5 39. ICM admits that on or about August 2004, ICANN did not accept
6 ICM's application. ICM denies the remaining allegations of Paragraph 39 and all
7 of each of its subparagraphs.

8 40. ICM admits that on or about June 1, 2005, ICANN authorized ICM to
9 enter into negotiations for the .XXX TLD. ICM denies the remaining allegations
10 of Paragraph 40.

11 41. ICM lacks sufficient information to form a belief as to the truth of the
12 allegations relating to the opposition to the .XXX TLD. ICM denies the remaining
13 allegations of Paragraph 41.

14 42. ICM admits it made Freedom of Information Act ("FOIA") requests
15 and filed a lawsuit to force publication of redacted documents under the FOIA
16 against the Department of State and Department of Commerce. ICM admits that
17 its May 19, 2006 complaint states that "the comments filed in ICANN's evaluation
18 period regarding ICM's .xxx sTLD proposal were overwhelmingly favorable" and
19 that "negative lobbying campaign was initiated by a few U.S.-based activist groups
20 in response to ICANN's June 1, 2005 vote in support of the ICM application."
21 ICM admits that it submitted a complaint to the ICANN ombudsman about
22 ICANN's treatment of ICM's .XXX TLD application. ICM denies the remaining
23 allegations of Paragraph 42.

24 43. ICM admits that ICANN did not accept ICM's .XXX proposed
25 registry agreement on or about May 10, 2006. ICM admits that on or about May
26 19, 2006, ICM filed, and later withdrew, a request for reconsideration about the
27 ICANN Board's decision not to execute the contract. ICM admits that on or about
28 March 30, 2007, ICANN did not accept ICM's proposed registry agreement for the

1 .XXX sTLD and rejected the application in full. ICM lacks sufficient information
2 to form a belief as to the truth of the remaining allegations of Paragraph 43 and
3 therefore denies those allegations.

4 44. ICM admits that on or about June 6, 2008, ICM filed an Independent
5 Review Proceeding (“IRP”) challenging ICANN’s denial of the .XXX TLD. ICM
6 admits that in its IRP, ICM contended that ICANN had approved ICM’s
7 application for the .XXX TLD in June 2005 and directed that ICANN’s President
8 and General Counsel begin negotiating an agreement with ICM, and that ICANN’s
9 Board subsequently improperly rejected the ICM application. ICM denies the
10 remainder of the allegations in Paragraph 44. Alternatively, ICM lacks sufficient
11 information to form a belief as to the truth of the remaining allegations of
12 Paragraph 44 and therefore denies those allegations.

13 45. ICM admits its June 6, 2008 Request for IRP states that “[t]here is
14 substantial industry support for the .XXX domain, as evidenced by the number of
15 providers that have participated in ICM’s pre-reservation program, which allows
16 for applicants to reserve domain names in advance of the approval of the sTLD
17 application.” ICM admits it also made this statement in its January 22, 2009.
18 “Memorial on the Merits.” ICM denies the remainder of the allegations in Paragraph
19 45.

20 46. ICM admits that on February 19, 2010, the majority of a three-person
21 Independent Review Panel issued a Declaration that ICANN had in June 2005
22 determined that ICM met the sponsorship criteria, and that ICANN could not
23 thereafter properly reopen the issue. ICM lacks sufficient information to form a
24 belief as to the truth of the remaining allegations of Paragraph 46 and therefore
25 denies those allegations.

26 47. ICM admits that on March 26, 2010, ICANN publicly posted a
27 document listing options for responding to the IRP declaration and that the posting
28 noted that ICANN could accept the majority decision or could adopt the dissenting

1 decision. ICM denies the allegations as to its “response” to ICANN. ICM denies
2 the allegations as threats of litigation. ICM denies the remainder of the allegations
3 in Paragraph 47.

4 48. ICM admits that on March 18, 2011, ICANN agreed with ICM to
5 approve ICM’s application for the .XXX TLD. ICM admits that on March 31,
6 2011, ICANN and ICM signed a registry contract under which ICM agreed to
7 provide registry services for the .XXX TLD. ICM denies the remainder of the
8 allegations in Paragraph 48.

9 49. ICM admits that ICANN agreed with ICM to approve the .XXX TLD
10 and entered into a registry contract. ICM lacks sufficient information to form a
11 belief as to the truth of the remaining allegations of Paragraph 49 and therefore
12 denies those allegations.

13 50. ICM denies the allegations of Paragraph 50. Alternatively, ICM lacks
14 sufficient information to form a belief as to the truth of the allegations of
15 Paragraph 50 and therefore denies those allegations.

16 51. ICM denies the allegations of Paragraph 51.

17 52. Paragraph 52 contains no charging allegations against ICM. ICM is
18 therefore not required to admit or deny the allegations. Alternatively, ICM lacks
19 sufficient information to form a belief as to the truth of the allegations of
20 Paragraph 52 and therefore denies the same.

21 53. ICM admits the allegations as to the terms of the Registry Agreement
22 with ICANN, except as to the allegations regarding “substantial fees” which
23 allegations ICM denies. Alternatively, ICM lacks sufficient information to form a
24 belief as to the truth of the allegations regarding “substantial fees” in Paragraph 53
25 and therefore denies the same.

26 54. ICM lacks sufficient information to form a belief as to the truth of the
27 allegations of Paragraph 54 and therefore denies the same.

28 ///

1 55. ICM denies the allegations as to any combination or conspiracy with
2 ICANN. ICM denies the remainder of the allegations in Paragraph 55.

3 Alternatively, ICM lacks sufficient information to form a belief as to the truth of
4 the remaining allegations of Paragraph 55 and therefore denies the same.

5 56. ICM admits the Registry Agreement with ICANN does not contain
6 price restrictions for .XXX registry services. ICM admits that the Registry
7 Agreement states that the “Registry Operator [ICM] may terminate this Agreement
8 and its designation as Registry Operator for the TLD pursuant to 120 days prior
9 notice in writing to ICANN, and subject to compliance with Section 6.4 hereof.”
10 ICM admits that the Registry Agreement states that “ICANN may terminate this
11 Agreement if Registry Operator [ICM] fails to cure any fundamental and material
12 breach of Registry Operator’s obligations set forth in Sections 3.1(a), (b), (d) or (e);
13 Section 5.2 or Section 7.2 despite notice and a reasonable opportunity to cure in
14 accordance with Section 6.3.” ICM admits the Registry Agreement states that the
15 “initial term of [the] Agreement shall expire ten years from the Effective Date” and
16 that the Registry Agreement states that is “shall be renewed upon the expiration of
17 the term set forth in Section 4.1 above and each renewal term, unless: (i) an
18 arbitrator or court has determined that Registry Operator has been in fundamental
19 and material breach of Registry Operator's obligations set forth in Sections 3.1(a),
20 (b), (d), (e) or (h); Section 5.2 or Section 7.2 and (ii) following the final decision of
21 such arbitrator or court, Registry Operator has failed to comply within ten days with
22 the decision of the arbitrator or court, or within such other time period as may be
23 prescribed by the arbitrator or court, provided, however, that Registry Operator
24 agrees that any renewal of this Agreement is conditioned on its negotiation of
25 renewal terms reasonably acceptable to ICANN, taking into account the terms of
26 existing registry agreements with respect to similarly situated TLDs.” ICM denies
27 the remaining allegations of Paragraph 56 and each of its subparagraphs.

28 Alternatively, ICM lacks sufficient information to form a belief as to the truth of the

1 remaining allegations of Paragraph 56 and each of its subparagraphs and therefore
2 denies the same.

3 57. ICM denies the allegations of Paragraph 57.

4 58. ICM denies the allegations of Paragraph 58.

5 59. Paragraph 59 contains no charging allegations against ICM. ICM is
6 therefore not required to admit or deny the allegations. Alternatively, ICM lacks
7 sufficient information to form a belief as to the truth of the allegations of
8 Paragraph 59 and therefore denies the same.

9 60. ICM denies the allegations of Paragraph 60. Alternatively, ICM lacks
10 sufficient information to form a belief as to the truth of the allegations of
11 Paragraph 60 and therefore denies those allegations.

12 61. ICM denies the allegations of Paragraph 61. Alternatively, ICM lacks
13 sufficient information to form a belief as to the truth of the allegations of
14 Paragraph 61 and therefore denies those allegations.

15 62. ICM denies the allegations of Paragraph 62. Alternatively, ICM lacks
16 sufficient information to form a belief as to the truth of the allegations of
17 Paragraph 62 and therefore denies those allegations.

18 63. ICM admits that the non-adult content websites onlineclasses.xxx,
19 musicvideos.xxx, discoverme.xxx, eflowers.xxx, rentacar.xxx, insurancerates.xxx,
20 and homesforsale.xxx are currently found on the .XXX TLD. ICM denies the
21 remaining allegations of Paragraph 63. Alternatively, ICM lacks sufficient
22 information to form a belief as to the truth of the remaining allegations of
23 Paragraph 63 and therefore denies those allegations.

24 64. ICM lacks sufficient information to form a belief as to the truth of the
25 allegations of Paragraph 64 and therefore denies those allegations.

26 65. ICM denies the allegations of Paragraph 65. ICM lacks sufficient
27 information to form a belief as to the truth of the allegations of Paragraph 66
28 regarding “other company or entity” and therefore denies those allegations.

1 66. ICM denies the allegations of Paragraph 66.

2 67. ICM denies the allegations of Paragraph 67. ICM lacks sufficient
3 information to form a belief as to the truth of the allegations of Paragraph 67
4 regarding “other company or entity” and therefore denies those allegations.

5 68. ICM denies the allegations of Paragraph 68. Alternatively, ICM lacks
6 sufficient information to form a belief as to the truth of the allegations of
7 Paragraph 68 and therefore denies those allegations.

8 69. ICM denies the allegations of Paragraph 69. Alternatively, ICM lacks
9 sufficient information to form a belief as to the truth of the allegations of
10 Paragraph 69 and therefore denies those allegations.

11 70. ICM denies the allegations of Paragraph 70.

12 71. Paragraph 71 contains no charging allegations against ICM. ICM is
13 therefore not required to admit or deny the allegations. Alternatively, ICM lacks
14 sufficient information to form a belief as to the truth of the allegations of
15 Paragraph 71 and therefore denies the same.

16 72. ICM denies the allegations of Paragraph 72.

17 73. ICM denies the allegations of Paragraph 73. Alternatively, ICM lacks
18 sufficient information to form a belief as to the truth of the allegations of
19 Paragraph 73 and therefore denies the same.

20 74. ICM admits that its permanent blocking services were limited to exact
21 match trademarks. ICM denies the remaining allegations of Paragraph 74.
22 Alternatively, ICM lacks sufficient information to form a belief as to the truth of
23 the remaining allegations of Paragraph 74 and therefore denies those allegations.

24 75. ICM admits that its permanent blocking services were limited to exact
25 match trademarks. ICM denies the remaining allegations of Paragraph 75.
26 Alternatively, ICM lacks sufficient information to form a belief as to the truth of
27 the remaining allegations of Paragraph 75 and therefore denies those allegations.

28 ///

1 76. ICM admits that it limited the sale of permanent blocking rights to a
2 certain time period, known as the “Sunrise B” period, which has now expired.
3 ICM admits that its permanent blocking services under its “Sunrise B” reservation
4 services program were limited to “registered trademark[s]” that “must be a trade or
5 service mark registration of national or regional international effect issued prior to
6 1 September, 2011 and in use in Eligible Commerce by the Applicant.” ICM
7 denies the remaining allegations of Paragraph 76 and each of its subparagraphs.
8 Alternatively, ICM lacks sufficient information to form a belief as to the truth of
9 the remaining allegations of Paragraph 76 and each of its subparagraphs and
10 therefore denies those allegations.

11 77. ICM denies the allegations of Paragraph 77. Alternatively, ICM lacks
12 sufficient information to form a belief as to the truth of the allegations of
13 Paragraph 77 and therefore denies those allegations.

14 78. ICM admits that it charges \$60, plus a \$2 fee for ICANN pursuant to
15 the Registry Agreement, for a total of \$62 for .XXX TLD registrations. ICM
16 denies the remaining allegations of Paragraph 78. Alternatively, ICM lacks
17 sufficient information to form a belief as to the truth of the remaining allegations
18 of Paragraph 78 and therefore denies those allegations.

19 79. ICM denies the allegations of Paragraph 79. Alternatively, ICM lacks
20 sufficient information to form a belief as to the truth of the allegations of
21 Paragraph 79 and therefore denies those allegations.

22 80. ICM denies the allegations of Paragraph 80. Alternatively, ICM lacks
23 sufficient information to form a belief as to the truth of the allegations of
24 Paragraph 80 and therefore denies those allegations.

25 81. ICM denies the allegations of Paragraph 81.

26 82. ICM denies the allegations of Paragraph 82. Alternatively, ICM lacks
27 sufficient information to form a belief as to the truth of the allegations of
28 Paragraph 82 and therefore denies those allegations.

1 83. ICM lacks sufficient information to form a belief as to the truth of the
2 allegations of Paragraph 83 and each of its subparagraphs and therefore denies
3 those allegations.

4 84. ICM admits that its October 6, 2011 press release states: “ICM has
5 now sold nine premium .XXX domain names for \$100,000 or more, which is
6 unparalleled in any other domain launch and reports that there are many other
7 similar deals in progress. ‘Domain names in most other TLDs typically sell for 1-
8 10% of the value of the .com equivalent. The .XXX names are already selling for
9 30-40% and we are just getting started[.]’” ICM admits that it also announced a
10 \$1.65 million sale for a collection of .XXX domain names, and a \$500,000 sale for
11 a single .XXX domain name. ICM admits that the October 6, 2011 press release
12 states that the \$500,000 sale price was “the highest price ever paid for a domain
13 name in any extension pre-launch. This is also the 5th highest sale price of any
14 domain name sold in 2011 and one of the top 30 most expensive domain names
15 sold in the last 3 years.” ICM denies the remaining allegations of Paragraph 84.
16 Alternatively, ICM lacks sufficient information to form a belief as to the truth of
17 the remaining allegations of Paragraph 84 and therefore denies those allegations.

18 85. ICM admits that it currently charges \$60, plus a \$2 fee for ICANN
19 pursuant to the Registry Agreement, for a total of \$62 for annual registrations.
20 ICM denies the remaining allegations of Paragraph 85. Alternatively, ICM lacks
21 sufficient information to form a belief as to the truth of the remaining allegations
22 of Paragraph 85 and therefore denies those allegations.

23 86. ICM admits that its agreement for premium registry services states
24 that “Potential Registrant shall not act in a manner that might reasonably be
25 construed to disparage or detriment ICM Registry or the .xxx top level domain . . .”
26 ICM denies the remaining allegations of Paragraph 86. Alternatively, ICM lacks
27 sufficient information to form a belief as to the truth of the remaining allegations
28 of Paragraph 86 and therefore denies those allegations.

- 1 87. ICM denies the allegations of Paragraph 87.
- 2 88. ICM denies the allegations of Paragraph 88.
- 3 89. ICM denies the allegations of Paragraph 89.
- 4 90. ICM denies the allegations of Paragraph 90.
- 5 91. ICM denies the allegations of Paragraph 91
- 6 92. ICM denies the allegations of Paragraph 92.
