Name of Proposed Service:

INFO Specification Update request

Technical description of Proposed Service:

Background:

Afilias signed a new Registry Agreement with ICANN, which was executed on 22 August 2017. Specifications were attached as appendices. Since the new gTLD program was just getting started in earnest, all the ramifications and details of the specifications were not completely finalized. However, clear intent is evidenced in the INFO specs that Afilias desired for the specifications to conform to the new gTLD standard as soon as it stabilized. Evidence of this is as follows:

- o The Registry Operator Monthly Reports Appendix, which corresponds to the new gTLD Specification 3, and the Service Level Agreements Appendix, which corresponds to Specification 10, are for all intents and purposes identical.
- o The Data Escrow Specification Appendix, which corresponds to the new gTLD Specification 2, and the Whois Specifications Appendix, which corresponds to the new gTLD Specification 4, have similar intent, and indicate similar operational parameters and outcomes, even though the language is somewhat variant.
- o The Zone File Access Agreement, which corresponds to the new gTLD Specification 6, is introduced with this language: "Registry Operator and ICANN agree to engage in good faith negotiations to replace this Appendix 3 with the Zone File Access provisions equivalent to that of new gTLD registry operators within 90 days after the final new gTLD Registry Agreement has been approved by the ICANN Board of Directors." It can be assumed that this intent extends to all the specifications.

Therefore, since ICANN and Afilias have both expressed interest in legacy TLDs, specifically INFO, conforming to the new gTLD specifications, Afilias hereby requests that the set of new gTLD specifications replace the existing set of INFO appendices in toto.
