Technical description of Proposed Service:

.QPON Domains seeks to allow registrars to register the aforementioned IDN languages at the second level, by querying the registry system with the PUNY code variation of each IDN SLD. .QPON Domains, through its back-end provider, Neustar, already offers IDN registrations for Spanish. Thus far, there have been no technical issues with the Spanish IDN offering, and

We did not feel it was necessary to have consultations with the community because it is very common that IDNs are offered from most TLDs, as well as we already have an IDN for the Spanish language, with no objections, issues, or concerns from the community.

N/A. .QPON is not a sponsored TLD.

Neustar said they never had any Registrars object to having IDNs added, and we feel that offering a wider variety of languages allows for a wider use of the Internet users, and our obligation to offer the availability to as many people from different cultures around the globe. Neustar already offers the proposed IDNs at all of the Registrars that we have in our Registrar Network.

Expanding the .QPON's IDN offerings to a level already offered by a number of other registries, constituency consultation did not seem necessary. It's very common, and we haven't heard of any issues or conflicts regarding offering multiple IDNs.

If approved, .QPON intends to implement the new IDNs within 3 to 6 months. Chinese, Japanese, and German will be the first ones we will implement.

Every registrar that has signed an RRA for .QPON will be granted the opportunity to offer all of the IDNs, on non-discriminatory and equal terms.

The expanded IDNs will be offered to the Registrars at the same fee rate as the non-IDN offerings and the current Spanish IDN offerings.

Describe quality assurance plan or testing of Proposed Service:

Neustar is experienced and has executed this process many times in the past. The same quality assurance will be given as

promote Chinese IDN registration primarily in China, and German IDN registration primarily in Germany. However, we are sensitive to the fact that languages are spoken outside of their place of origin, and we are therefore placing no geographical restrictions on registration of IDNs.

What companies/entities provide services or products that are similar in substance or effect to your proposed Registry Service?:

.biz, .co TLDs. Other TLD registry operators have chosen to offer a broad array of IDN languages, including Google, Verisign, Donuts, dotLatin, and Neustar (among many others). All Registry Operators who offer IDN registrations at the second level offer the same services we seek to offer.

In view of your status as a registry operator, would the introduction of your proposed Registry Service potentially impair the ability of other companies/entities that provide similar products or services to compete?:
