

## **Amendment No. 2 to Registry Agreement**

The Internet Corporation for Assigned Names and Numbers and ShortDot SA agree, effective as of \_\_\_\_\_ (“Amendment No. 2 Effective Date”), that the modification set forth in this amendment No. 2 (the “Amendment”) is made to the 08 January 2015 .ICU Registry Agreement between the parties, as amended (the “Agreement”).

The parties hereby agree to amend Exhibit A of the Agreement by adding the following new text as a new Section 5:

### **“5. Internationalized Domain Names (IDNs)**

Registry Operator may offer registration of IDNs at the second and lower levels provided that Registry Operator complies with the following requirements:

- 5.1. Registry Operator must offer Registrars support for handling IDN registrations in EPP.
- 5.2. Registry Operator must handle variant IDNs as follows:
  - 5.2.1. By default variant IDNs (as defined in the Registry Operator’s IDN tables and IDN Registration Rules) must be blocked from registration.
  - 5.2.2. Variant IDNs may be activated when requested by the sponsoring Registrar of the canonical name as described in the IDN Tables and IDN Registration Rules.
  - 5.2.3. Active variant IDNs must be provisioned in the TLD’s DNS zone file as zone cuts using the same NS resource records as the canonical name.
- 5.3. Registry Operator may offer registration of IDNs in the following languages/scripts (IDN Tables and IDN Registration Rules will be published by the Registry Operator as specified in the ICANN IDN Implementation Guidelines):
  - 5.3.1. Chinese language
  - 5.3.2. Czech language
  - 5.3.3. Danish language
  - 5.3.4. French language
  - 5.3.5. German language
  - 5.3.6. Greek script
  - 5.3.7. Hebrew language
  - 5.3.8. Icelandic language

- 5.3.9. Italian language
- 5.3.10. Japanese language
- 5.3.11. Korean language
- 5.3.12. Lao language
- 5.3.13. Latin script
- 5.3.14. Luxembourgish language
- 5.3.15. Portuguese language
- 5.3.16. Romanian language
- 5.3.17. Russian language
- 5.3.18. Spanish language
- 5.3.19. Turkish language
- 5.3.20. Ukrainian language”

All capitalized terms not defined will have the meaning given to them in the Agreement.
