Please be advised that as of 13 September 2018, JIANGSU CHENGFUTONG NETWORK TECHNOLOGY CO., LTD.'s ("Jiangsu Chengfutong") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 18 May 2017 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 28 September 2018, 15 calendar days from the date of this notice.

This termination is due to Jiangsu Chengfutong's failure to timely cure the breach by 12 September 2018 as set forth in ICANN's notice of breach dated 22 August 2018. As of 13 September 2018, the following breach remains:

1. Jiangsu Chengfutong's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additionally, Jiangsu Chengfutong failed to provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that Jiangsu Chengfutong will (a) timely respond to ICANN compliance matters and (b) timely make payment of its ICANN fees.

Please see the chronology below for additional details.

Jiangsu Chengfutong is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 28 September 2018. Please remove all ICANN trademarks, name and logo from Jiangsu Chengfutong's website and business materials that have been licensed to Jiangsu Chengfutong under the terms of that Specification by 28 September 2018.

Domain Name Transition Process

No domain names are currently managed by Jiangsu Chengfutong. Therefore, ICANN does not need to follow the [De-Accredited Registrar Transition Procedure](#) (“Procedure”).

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Jiangsu Chengfutong has current and past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
