Please be advised that, as of 29 June 2022, Innovadeus Pvt. Ltd.'s ("Innovadeus" or "Registrar") 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 17 May 2018 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 15 July 2022, 16 calendar days from the date of this Termination Notice pursuant to the terms of the RAA.

The termination is due to Innovadeus's failure to timely cure the breaches by 26 May 2022 as set forth in ICANN's Notice of Breach of RAA dated 5 May 2022. As of 29 June 2022, the following breaches remain:

1. Innovadeus's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Additionally, Innovadeus has failed to:

2. Publish on its website(s) and/or provide a link on its website to the Registrants' Benefits and Responsibilities Specification, as required by Section 3.7.10 of the RAA.
3. Include a link in its registration agreement to its renewal fees, post-expiration renewal fees (if different) and redemption/restore fees, as required by Section 4.1 of the Expired Registration Recovery Policy ("ERRP").
4. Provide in its registration agreement a description of the methods used to deliver pre- and post-expiration notifications, as required by Section 4.2 of the ERRP.

Domain Name Transition Process

To protect domain name registrants, ICANN will follow the [De-Accredited Registrar Transition Procedure](#) in order to transition the domain names currently managed by Innovadeus to a qualified ICANN-accredited registrar.

ICANN Logo License

Innovadeus is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 15 July 2022. Please remove all ICANN trademarks, name, and logo from Innovadeus's website and business materials that have been licensed to Innovadeus under the terms of that Specification by 15 July 2022.

ICANN reserves all of its rights under the RAA. Please note the rights and obligations required to continue in effect after the expiration of the RAA, including but not limited to: Sections 3.4 Retention of Registered Name Holder and Registration Data; 3.9 Accreditation Fees; 5.8 Resolution of Disputes Under this Agreement; and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Innovadeus has past due accreditation fees. Please immediately submit payment to ICANN Accounting.
