WHEREAS, on October 30, 2012, Plaintiff name.space, Inc. (“name.space”) and Defendant Internet Corporation for Assigned Names and Numbers (“ICANN”) entered into a stipulation pursuant to L.R. 8-3 setting November 30, 2012 as the deadline for ICANN to answer or otherwise respond to name.space’s Complaint in this action [ECF No. 10];

WHEREAS, on November 26, 2012, the parties participated in a conference of counsel pursuant to L.R. 7-3 regarding ICANN’s contemplated motion to dismiss;

WHEREAS, ICANN intends file its motion to dismiss on or before November 30, 2012; and

WHEREAS, following the November 26, 2012 conference, the parties have agreed upon a briefing schedule that they believe is necessary for a full and fair discussion of the issues to be raised in Defendant’s motion to dismiss, particularly in light of the upcoming holidays;

THEREFORE, the parties, through their undersigned counsel, hereby stipulate and agree, subject to the Court’s approval, as follows:

- (1) Plaintiff’s opposition to Defendant’s motion to dismiss shall be due on or before January 11, 2013;
- (2) Defendant’s reply brief in further support of its motion to dismiss shall be due on or before January 25, 2013; and
- (3) The hearing on Defendant’s motion to dismiss will be scheduled for February 11, 2013.
