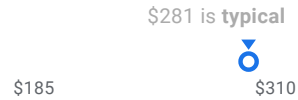

Counsel:

Enclosed please find ICANN's objections and responses to the notice of 30(b)(6) deposition you recently served upon ICANN, identifying 48 topics for examination. We have also sent you a hard copy by mail.

As an initial matter, the noticed deposition date is June 3, 2016, which falls before the parties' June 6, 2016 Rule 26(f) conference, in contravention of the applicable Federal Rules of Civil Procedure. Fed. R. Civ. P. 30(a)(2)(A)(iii); Fed. R. Civ. P. 26(d)(1). Once we have met and conferred regarding the topics of examination, we can arrange a mutually acceptable date after the Rule 26(f) conference for the deposition to take place.

As set forth in more detail in ICANN's objections, a number of the topics are significantly overbroad, or seek privileged or irrelevant information. Moreover, the breadth of topics this deposition notice seeks to cover would render the deposition unfeasible in light of the seven hour limit, especially given that ICANN would need to designate a substantial number of witnesses to cover all of the topics currently requested.

We would like to set up a time at your earliest convenience to meet and confer (in person, per C.D. Cal. L. R. 37-1) regarding these issues. In the event that we do not agree on a narrowed set of deposition topics during the meet and confer session, we intend to file an ex parte application for a protective order with the Court. However, we would like to avoid that motion practice and instead reach a compromise solution. Please advise as to your availability next week for

an in person meeting, perhaps by suggesting two or three times that would work for you.

Separately, moving forward, we would like to reach an agreement that email service is to effectuate proper service for all documents in this matter. Please let me know whether you agree to accept email service.
